In certain circumstances where the Issuer has or will become obligated to pay additional amounts (as described in the pricing supplement), the Issuer may, at its option, redeem the Notes, in whole, but not in part, at any time before maturity, after giving not less than 10 nor more than 60 calendar days' notice to the holders of the Notes, at a redemption price equal to 100% of their principal amount together with accrued interest, if any, to, but excluding, the redemption date. The Issuer may also redeem the Notes, at its option, as a whole or in part at any time and from time to time, prior to maturity, after giving not less than 10 nor more than 60 calendar days' notice to the holders of the Notes at a redemption price equal to the sum of (i) 100% of the principal amount of the Notes to be redeemed; (ii) the Make-Whole Amount (as defined in the pricing supplement dated December 4, 2023) discounted at the Treasury Yield (as defined in the pricing supplement) plus 15 basis points; and (iii) accrued and unpaid interest on the Notes to, but excluding, the redemption date. See "Terms of the Notes — Optional Redemption" in the pricing supplement.

Use of Proceeds:	The Issuer intends to use an amount equal to the net proceeds of the sale of the Notes to fund the financing or refinancing of specified green projects and activities as described under "Use of Proceeds" in the Preliminary Pricing Supplement.
