### Ed Clark's Recent Speech Highlights the Importance of Philanthropy



Ed Clark, recently retired as President and C.E.O of TD

On November 19, 2014, Ed Clark, who recently retired as the President and C.E.O of TD, delivered a speech at the Economic Club in Toronto, outlining his personal philanthropic vision. He said in part:

"My speech is quite simple: it is a shameless attempt to try to convince you, if you are not already convinced, that you should have, for self-interest broadly defined, a philanthropy budget that corresponds with your income, and equally important, your wealth.

We are blessed to live in a country like Canada. But we would be unwise not to recognize that the rising cost of housing materially impacts the reality of those earning in the bottom half of society... I realized that if I wanted to make an impact, I had to apply the same kind of systematic approach in my charitable efforts as I do in operating a business. I had to think of my donations of money and time as a strategic allocation of resources.... Don't expect our politicians to take the lead on each and every social issue – not unless you are prepared to provide them with more money to do so.

We have wonderful not-for-profit organizations – we need to back them...

I have three asks of you.

**First:** set aside a portion of your philanthropy budget for social issues. Yes, give back to universities who helped you or your children. Support our wonderful health care system that makes Canada what it is. And help support our cultural institutions. But if we truly want Toronto to be a livable city, and one of which we can be proud, we need everyone to carve out an important share for social giving. **Second:** use not only your money but your skills and connections to help solve social ills..... You have the skills and resources to make that a reality. And **Third:** in doing so, never divorce what you are doing from the individuals, the people, the humans who are just like you and I, who will benefit from your generosity. These are not abstract.

While tax return-eligible receipts are available through several large, international global charities in Canada, many Canadians want to support different global projects, or in many instances, to start one of their own.



**Find a project fund:** Make a contribution into an established International Project Fund (IPF). Each IPF is designated for a project that CAF Canada has created for one of its partner organizations. Donors can make a contribution into one such fund to help CAF Canada begin the implementation of these projects.

**Support a new project fund:** Connect with CAF Canada and identify a geographic location and/or social issue to support. Using its vast network of partner NGOs and support from other CAF offices, CAF Canada will locate and/or suggest an appropriate fund that matches your criteria. If it is a new project, they will select an organization and develop a designated project that best fits the given criteria.

# Women and Philanthropy in Canada: first thought leadership report released by TD!

Women are playing an increasing role in charitable giving and philanthropy in Canada. The report titled, Time, Treasure, Talent: Canadian Women and Philanthropy, is an examination of the roles, attitudes, and expectations of Canadian women philanthropists. The paper forms part of TD's "Your Story, Your Future" thought leadership series for women investors, one pillar of TD's Women Investor Strategy, which is a broad initiative to better understand and meet the investing needs of Canadian women. Among the key findings of the report are these interesting facts and statistics:

- Canadian women control approximately one-third of household wealth in Canada, or approximately \$3.2 trillion in total assets
- In the past five years, the number of female donors in Canada has greatly exceeded that of male donors
- Approximately 350,000 women in Canada have both the access to the financial resources and the desire needed to make a major gift to charity
- Affluent women are nearly twice as likely as men to say that charitable giving is the most satisfying part of having wealth
- The wealth transfer in Canada between 2012 and 2022 is estimated to be \$896 billion, with approximately \$600 billion flowing into the hands of women either as spouses, daughters or partners

In October 2004, the Private Giving Foundation (PGF) was introduced by TD as the first donor-advised fund program launched by a financial institution in Canada. This fall marks our tenth anniversary! The PGF provides a simple, tax-effective alternative to establishing a private foundation in order to leave a legacy of giving and to support the causes that matter to you. The foundation concept is now easily accessible to many, since a minimum of only \$10,000 is required to establish a fund within PGF. The PGF is the beneficiary of over 750 donor-advised funds, and continues to grow. It has received contributions of over \$240 million, and has distributed over \$75 million to charities. We are so proud of this achievement!
