This interim management report of fund performance represents management's view of the significant factors and developments affecting the investment fund's performance and outlook since December 31, 2023, the investment fund's fiscal year-end, until June 30, 2024. This report should be read in conjunction with the 2023 annual management report of fund performance.

Management Discussion of Fund Performance

Results of Operations

The D-Series units of TD Canadian Large-Cap Equity Fund (the "Fund") returned 4.1% for the six-month period ended June 30, 2024 (the "Reporting Period"), versus 4.9% for the Fund's product benchmark, the S&P/TSX 60 Total Return Index. Unlike the product benchmark, the Fund's return is quoted after the deduction of fees and expenses. Returns for other series of the Fund may vary, largely due to differences in fees and expenses. Refer to the Past Performance section for returns of various series of the Fund.

Market Update

Towards the end of the Reporting Period, the Bank of Canada ("BoC") lowered its benchmark overnight interest rate by 0.25% to 4.75%, the first rate cut since 2020. The BoC believed a rate reduction was warranted at this time, with inflationary pressures easing and relatively slow economic conditions. Although Canada's economy has expanded, the pace of growth was modest. A rise in consumer and business spending drove growth in the first quarter of 2024. Conversely, the manufacturing sector contracted over the Reporting Period due to weaker demand, which weighed on Canada's economic health. Canada's inflation rate remained above the BoC's 2% target, however, it eased due to a slowdown in food and energy price growth. Canada's central bank acknowledged inflation remains a risk and suggested future interest rate reductions might be gradual. Canada's labour market, a source of strength for the economy coming out of the pandemic, showed signs of cooling. While the economy added jobs, it did not keep up with the pace of population growth, which pushed the unemployment rate higher.

The Canadian equity market rose over the Reporting Period, with six of 11 sectors posting positive returns. Canadian equities benefited from the BoC beginning to lower interest rates, as well as from the relative resiliency of the Canadian and U.S. economies. The materials, energy and consumer staples sectors were the strongest performers, while communication services, real estate and health care were the weakest-performing sectors.

Amid high inflation and economic uncertainty, investors turned to the relative safety of gold, which pushed the materials sector higher over the Reporting Period. Global central banks also stocked up on gold, and gold prices reached new record highs. Within the energy sector, production cuts from the Organization of the Petroleum Exporting Countries ("OPEC") and allies helped drive oil prices higher. Demand remained relatively resilient despite tight financial conditions. The defensive consumer staples sector rose as Canadian consumers largely focused their spending on essentials in response to high inflation and borrowing costs.

Key Contributors/Detractors

The Fund generated a positive return over the Reporting Period but underperformed its product benchmark.

- Security selection within the financials sector detracted from performance owing to the Fund's positions in Bank of Montreal and The Toronto-Dominion Bank, both of which were down approximately 10% during the Reporting Period.
- The Fund's overweight exposure to the communication services sector detracted from performance as it was one of the weakest-performing sectors during the Reporting Period.
- An underweight allocation to the materials sector detracted from performance as this sector outperformed the product benchmark.
- Stock selection within the information technology sector contributed to performance owing to the Fund's lack of exposure to Shopify Inc., which was down approximately 10%.
- Security selection within the consumer discretionary sector contributed to performance owing to the Fund's position in a discount retail store chain that returned over 30% and its lack of exposure to Restaurant Brands International Inc., which was down approximately 5%.

Recent Developments

The Portfolio Adviser expects global economic activity to remain relatively modest in 2024, as a result of tight financial conditions, geopolitical tensions, and softer demand from consumers and businesses. Given relatively weak economic conditions and moderating inflation, global central banks are expected to begin lowering interest rates. This could help reignite economic growth over the second half of 2024 and help the global economy avoid a recession.

The Canadian economy was surprisingly resilient over the last year, shifting the economic debate from whether or not Canada will have a severe recession, to whether the Canadian economy will continue growing at a faster-than-expected pace or slow down as widely anticipated.

In June, the BoC reduced its benchmark interest rate from 5.00% to 4.75%. In the Portfolio Adviser's view, the first few interest rate cuts likely won't materially change individual consumption patterns, and many Canadians are financially constrained owing to higher prices and mortgage payments. However, interest rate cuts should provide confidence that better days are approaching. The Portfolio Adviser expects interest rate cuts to be slow and gradual, with one or two more cuts by the end of 2024.

From a sector perspective, the Portfolio Adviser continues to view banks favourably. Canadian banks reported positive second-quarter results, with the six big banks beating earnings per share estimates by 4% on average. Banks saw their first quarter of positive earnings growth in two years, and the Portfolio Adviser expects to see a return to normalized earnings growth over the next few quarters. Canadian banks appear reasonably valued, with an average dividend yield of more than 4%.

The Portfolio Adviser also continues to favour oil and gas producers as OPEC continues to hold back spare capacity, which the Portfolio Adviser believes should help oil trade in a range of US\$75 to US\$85, and allow Canadian oil producers to generate positive free cash flows. Oil companies are likely to return a large portion of these free cash flows to shareholders in the form of dividends, share buybacks and special dividends as they are close to meeting (or already have met) their debt targets.

Related Party Transactions

Affiliates of TD Asset Management Inc. ("TDAM") may earn fees and spreads in connection with various services provided to, or transactions with, the Fund, such as in connection with banking (including deposit taking), custody, securityholder account maintenance and reporting, brokerage and derivatives transactions.

Manager, Trustee and Portfolio Adviser:

TDAM, a wholly-owned subsidiary of The Toronto-Dominion Bank ("TD"), is the manager, trustee and portfolio adviser of the Fund. The Fund pays TDAM an annual management fee, which may vary for each series of the Fund. The Fund also pays TDAM an annual administration fee of 0.12%, calculated and accrued as a percentage of the net asset value, with respect to the D-Series units of the Fund.

Distributor:

Certain series of units of the Fund are distributed through brokers and dealers including TD Waterhouse Canada Inc. ("TDWCI"), a wholly-owned subsidiary of TD. TDWCI, like other dealers, is paid a trailer commission by TDAM for distributing certain series of units of the Fund. Trailer commissions are paid by TDAM out of the management fees it receives from the Fund and are based on the average value of assets held by each dealer.

Registrar and Transfer Agent:

TD is the registrar and transfer agent of the Fund, and as such maintains all unitholder records, processes purchase, switch, conversion and redemption orders, issues investor statements and prepares annual tax reporting information on behalf of the Fund.

TD earns a foreign exchange spread when unitholders switch between units of funds denominated in different currencies. The Fund also maintains bank accounts and overdraft provisions with TD for which TD earns a fee.

Administration and Securityholder Services:

TDWCI, in addition to acting as a dealer, also provides administration and securityholder services to the Private Series units of the Fund for which such costs are reflected in the operating expenses for the Private Series units of the Fund. These services include securityholder account maintenance and reporting.

Custodian:

TD is the sub-custodian of the Fund and may hold a portion of the assets (including cash and investments) of the Fund.

Buying and Selling Securities:

TDAM has established an independent review committee ("IRC") which acts as an impartial and independent committee to review and provide recommendations or, if appropriate, approvals respecting any conflict of interest matters referred to it by TDAM. The IRC prepares, at least annually, a report of its activities for securityholders of the Fund. The report is available on the TDAM website at www.td.com/ca/en/asset-management or at the securityholder's request at no cost by contacting TDAM (see front cover).

The Fund relied on standing instructions from the IRC in respect of one or more of the following transactions:

- (a) trades in securities of TD or any affiliate or associate thereof;
- (b) investments in the securities of an issuer where TD Securities Inc., TDWCI, or any other affiliate of TDAM (a "Related Dealer") acted as an underwriter during the distribution of such securities and the 60-day period following the completion of the distribution of the underwritten securities;
- (c) purchases or sales of securities of an issuer from or to another investment fund or discretionary managed account managed by TDAM; and
- (d) purchases of securities from or sales of securities to a Related Dealer, where it acted as principal.

The relevant standing instructions require that securities transactions with related parties conducted by TDAM (i) are free from any influence by an entity related to TDAM and without taking into account any consideration relevant to an entity related to TDAM; (ii) represent the business judgment of TDAM uninfluenced by considerations other than the best interests of the Fund; (iii) comply with the applicable policies and procedures of TDAM; and (iv) achieve a fair and reasonable result for the Fund.

Brokerage Arrangements (000s):

From time to time, the Fund may enter into portfolio securities transactions with Related Dealers who may earn commissions or spreads provided that such trades are made on terms and conditions that are comparable to non-affiliated brokerages. During the Reporting Period, the Fund paid commissions to related parties amounting to \$5 or 6.6% of total commissions paid by the Fund for portfolio transactions in total.

The Fund measures fair value of its investments based on close market prices, where the close market price falls within the bid-ask spread or based on quotations from recognized dealers. As such, the Fund's accounting policies for measuring the fair value of investments in the financial statements are substantively consistent with those used in measuring the net asset value ("NAV") for transactions with unitholders.

There will be no duplication of management fees paid to TDAM or its affiliates. Any waivers or absorptions may be discontinued at any time by TDAM at its discretion without notice.

³ The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average NAV during the stated period. Where a Fund invests in units of any underlying fund, the TER presented for the Fund includes the portion of TERs, if available, of the underlying fund(s) attributable to this investment.

⁴ The Fund's portfolio turnover rate ("PTR") indicates how actively the Fund's portfolio adviser manages its investments. A PTR of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the stated period. The higher a fund's PTR, the greater the trading costs payable, directly or indirectly, by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the fiscal year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

⁵ The Fund does not pay any management fees or operating expenses with respect to the O-Series units of the Fund, but may have a MER as a result of its holdings in underlying fund(s), representing the weighted average MER of those underlying fund(s) for the reporting period.

Management Fees

As manager and trustee of the Fund, TDAM is responsible for the overall business and affairs of the Fund, including activities related to making units of the Fund available to investors, and providing, or arranging for the provision of, investment advisory services and marketing services to the Fund. In consideration for the provision of such services, each series of the Fund, other than Private Series units and O-Series units, pays TDAM a management fee.

Management fees are calculated and accrued on a daily basis for each applicable series based on the net asset value of that series and paid monthly to TDAM.

The simplified prospectus discloses a specified annual management fee rate that TDAM can charge for each series of the Fund. Where TDAM chooses to charge a management fee rate below the specified annual management fee rate, the difference represents a waiver of management fees. TDAM may waive all or a portion of the management fees being charged to the Fund, which may be discontinued at any time by TDAM at its discretion without notice to unitholders.

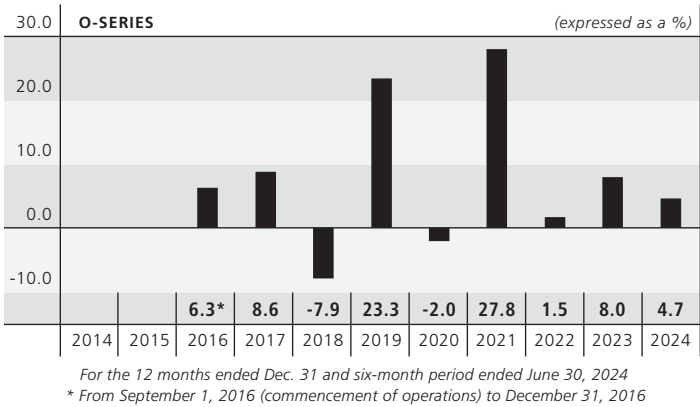
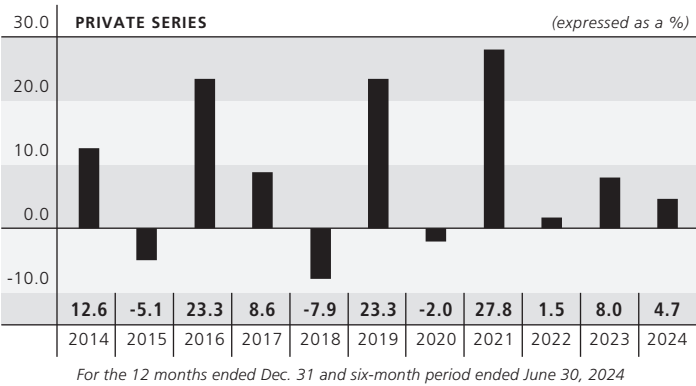
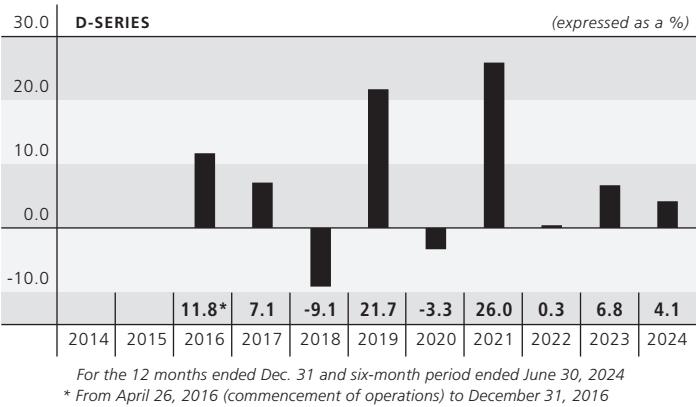
