What does the fund invest in?

The fund seeks to earn income with the potential for capital appreciation while following a socially responsible approach to investing. The fund may invest primarily in, or gain exposure to, North American equity and fixed income securities. The fund will focus on a combination of common share and bond investments that have strong sustainability characteristics and/or positively contribute toward the Sustainable Development Goals ("SDGs") as set out by the United Nations. The SDGs are a set of 17 integrated and indivisible goals set out by the United Nations, acting as a call for action by all countries to promote prosperity while protecting the planet. The SDGs address a range of global challenges, including those related to poverty, inequality, climate change, environmental degradation, peace and justice. The bond investments will also tend to focus on corporate bonds, which may include non-investment-grade bonds, using rigorous bottom-up security selection while also being mindful of the macro environment. In addition, the fund may, but is not required to, hedge any or all foreign currency exposure.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

TDAM has rated the volatility of this fund as low to medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.


How has the fund performed?

This section tells you how Investor Series securities of the fund performed over the past 3 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how Investor Series securities of the fund performed in each of the past 3 completed calendar years. The fund dropped in value in 1 of the 3 years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Investor Series securities of the fund in a 3-month period over the past 3 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

As of May 31, 2024, the annual compounded return of Investor Series securities of the fund was 4.5% since inception. If you had invested \$1,000 in Investor Series securities of the fund since inception, your investment would now be worth \$1,176.

How much does it cost?

1 Sales charges

This series is available on a "no-load" basis which means that you do not pay a sales charge when you buy this series.

2 Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2023, the fund's expenses were 2.08% of its average value. This equals \$20.80 for every \$1,000 invested.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

TDAM pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate is 0.00% to 1.00% of the value of your investment each year. This equals \$0.00 to \$10.00 each year for every \$1,000 invested.

3 Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.
