#### What does the fund invest in?

The fund seeks to provide income and moderate capital growth by investing primarily in stocks, bonds and other income-producing investments of North American companies. The fund may also invest in exchange-traded funds. In addition, the fund may invest in, or have exposure to, foreign securities to an extent that is not typically expected to exceed 90% of the total value of the assets of the fund at the time that foreign securities are purchased.

# How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

# **Risk rating**

TDAM has rated the volatility of this fund as low to medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.


#### How has the fund performed?

This section tells you how D-Series securities of the fund performed over the past 8 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### Year-by-year returns

This chart shows how D-Series securities of the fund performed in each of the past 8 completed calendar years. The fund dropped in value in 1 of the 8 years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



#### **Best and worst 3-month returns**

This table shows the best and worst returns for D-Series securities of the fund in a 3-month period over the past 8 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As of May 31, 2024, the annual compounded return of D-Series securities of the fund was 9.8% since inception. If you had invested \$1,000 in D-Series securities of the fund since inception, your investment would now be worth \$2,395.

## **1** Sales charges

This series is available on a "no-load" basis which means that you do not pay a sales charge when you buy this series.

#### 2 Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2023, the fund's expenses were 1.14% of its average value. This equals \$11.40 for every \$1,000 invested.

#### Management expense ratio (MER)

This is the total of the fund's management fee, administration fee and any expenses, costs or fees incurred by the fund which are not paid for by the manager.
