What does the fund invest in?

The fund seeks to generate a moderate level of income while preserving investment capital and liquidity and providing some potential for capital growth by investing primarily in units of TD Mutual Funds, with an emphasis on mutual funds with income generating potential. The fund may also invest directly in guaranteed investment certificates, bonds issued by the Canadian or provincial governments and strip bonds. The fund's neutral asset mix will generally provide exposure to 70% fixed income and 30% equities. The asset allocation will generally be maintained within ranges of 60% to 80% for fixed income and 20% to 40% for equities. In addition, the fund may have exposure to foreign securities to an extent that will vary from time to time and may be up to 100% of the total value of assets of the fund at the time that such exposure to foreign securities is obtained.

The charts below give you a snapshot of the fund's investments on August 31, 2024. The fund's investments will change.



How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

TDAM has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

This section tells you how W-Series securities of the fund performed over the past 5 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.




TD Managed Income Portfolio – W-Series

Year-by-year returns

This chart shows how W-Series securities of the fund performed in each of the past 5 completed calendar years. The fund dropped in value in 1 of the 5 years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for W-Series securities of the fund in a 3-month period over the past 5 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As of August 31, 2024, the annual compounded return of W-Series securities of the fund was 3.8% since inception. If you had invested \$1,000 in W-Series securities of the fund since inception, your investment would now be worth \$1,278.

Who is this fund for?

This fund may be suitable for investors who:

- are investing for the medium-term
- want mostly income combined with a moderate amount of capital growth
- can handle changes in the value of their investment
- prefer to have professional managers determine the selection and composition of their investments, as well as provide ongoing monitoring services
- are seeking some exposure to foreign markets

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay and/or when you pay depends on the tax laws where you live, the type of distributions made by the fund and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, you must include taxable fund distributions in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell W-Series securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1 Sales charges

This series is available on a "no-load" basis which means that you do not pay a sales charge when you buy this series.

2 Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of June 30, 2024, the fund's expenses were 0.52% of its average value. This equals \$5.20 for every \$1,000 invested.

Annual rate (as a % of the fund's value)

Management expense ratio (MER)

This is the total of the fund's management fee and any expenses, costs or fees incurred by the fund which are not paid for by the manager. TDAM waived some of the fund's expenses. If it had not done so, the MER would have been higher.

**TD Managed Income Portfolio – W-Series****3 Other fees**

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Other fees	What you pay
Short-term trading fee	Up to 2% of the purchase cost of the securities if you redeem them or switch them to another fund within 7 days of purchasing them. This fee goes to the fund.
Fee-for-service fee	This series is available to you if you have a fee-based or wrap account for which you pay a fee directly to your representative's firm. This series is available through TD Waterhouse and other firms authorized by TDAM.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or fund facts document, or
- cancel your purchase within 48 hours after you receive confirmation of your purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, fund facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
