### What does the fund invest in?

The fund seeks to provide a high level of after-tax income and steady growth by investing primarily in high-quality, high-yield common stocks of large Canadian companies. The fund may also use derivatives to gain exposure to such securities. In addition, the fund may invest in, or have exposure to, foreign securities to an extent that is not typically expected to exceed 30% of the total value of the assets of the fund at the time that foreign securities are purchased.

# How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### **Risk rating**

TDAM has rated the volatility of this fund as **medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### How has the fund performed?

This section tells you how Investor Series securities of the fund performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### Year-by-year returns

This chart shows how Investor Series securities of the fund performed in each of the past 10 completed calendar years. The fund dropped in value in 4 of the 10 years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



#### **Best and worst 3-month returns**

This table shows the best and worst returns for Investor Series securities of the fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As of May 31, 2024, the annual compounded return of Investor Series securities of the fund was 6.7% over the past 10 years. If you had invested \$1,000 in Investor Series securities of the fund 10 years ago, your investment would now be worth \$1,904.

How much you pay and/or when you pay depends on the tax laws where you live, the type of distributions made by the fund and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, you must include taxable fund distributions in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Investor Series securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

# 1 Sales charges

This series is available on a "no-load" basis which means that you do not pay a sales charge when you buy this series.

### 2 Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2023, the fund's expenses were 2.04% of its average value. This equals \$20.40 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

TDAM pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate is 0.00% to 1.00% of the value of your investment each year. This equals \$0.00 to \$10.00 each year for every \$1,000 invested.

## **3** Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Short-term trading fee	Up to 2% of the purchase cost of the securities if you redeem them or switch them to another fund within 7 days of purchasing them. This fee goes to the fund.
