## What does the ETF invest in?

TD Global Technology Innovators Index ETF seeks to track, to the extent reasonably possible and before the deduction of fees and expenses, the performance of a technology innovators index which measures the investment return of technology companies that are deemed to be innovators based on higher annual growth rates in revenue, return on invested capital and operating margin expansion relative to their peers, while eliminating mega-cap technology stocks that typically dominate an index. Currently, this ETF seeks to track the Solactive Global Technology Innovators Index (CA NTR) (or any successor thereto), an index calculated by Solactive AG which tracks the performance of securities of technology issuers that are deemed to be innovators based on higher annual growth rates in revenue, return on invested capital and operating margin expansion relative to their peers, while eliminating mega-cap technology stocks that typically dominate an index. This ETF may invest in and hold a proportionate share or a sampling of constituent securities of the index to seek to track the performance of that index. As an alternative to or in conjunction with investing in and holding the constituent securities, the ETF may also invest in other securities to obtain exposure to the constituent securities of the index in a manner that is consistent with the investment objectives of the ETF.

# How risky is it?

The value of the ETF can go down as well as up. You could lose money.

One way to gauge risk is to look at how much an ETF's returns change over time. This is called "volatility".

In general, ETFs with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. ETFs with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk rating

TDAM has rated the volatility of this ETF as high.

This rating is based on how much the ETF's returns have changed from year to year. It doesn't tell you how volatile the ETF will be in the future. The rating can change over time. An ETF with a low risk rating can still lose money.

# How has the ETF performed?


This section tells you how this ETF performed over the past 2 years.

Returns are calculated using the ETF's net asset value (NAV) and are after expenses have been deducted. These expenses reduce the ETF's returns. This means that the ETF's returns may not match the returns of the Solactive Global Technology Innovators Index (CA NTR).

# Year-by-year returns

This chart shows how this ETF performed in each of the past 2 completed calendar years. The ETF dropped in value in 1 of the 2 years.

The range of returns and change from year to year can help you assess how risky the ETF has been in the past. It does not tell you how the ETF will perform in the future.



## **Best and worst 3-month returns**

This table shows the best and worst returns for this ETF in a 3-month period over the past 2 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As of August 31, 2024, the annual compounded return of this ETF was -7.0% since inception. If you had invested \$1,000 in this ETF since inception, your investment would now be worth \$819.

## **Trading ETFs**

ETFs hold a basket of investments, like mutual funds, but trade on exchanges like stocks. Here are a few things to keep in mind when trading ETFs:

#### **Pricing**

ETFs have two sets of prices: market price and net asset value (NAV).

#### Market price

- ETFs are bought and sold on exchanges at the market price. The market price can change throughout the trading day. Factors like supply, demand, and changes in the value of an ETF's investments can affect the market price.
- · You can get price quotes at any time during the trading day. Quotes have two parts: bid and ask.
- The bid is the highest price a buyer is willing to pay if you want to sell your ETF units. The ask is the lowest price a seller is willing to accept if you want to buy ETF units. The difference between the two is called the "bid-ask spread".
- · In general, a smaller bid-ask spread means the ETF is more liquid. That means you are more likely to get the price you expect.

## Net asset value (NAV)

- · Like mutual funds, ETFs have a NAV. It is calculated after the close of each trading day and reflects the value of an ETF's investments at that point in time.
- NAV is used to calculate financial information for reporting purposes like the returns shown in this document.

#### **Orders**

There are two main options for placing trades: market orders and limit orders. A market order lets you buy or sell units at the current market price. A limit order lets you set the price at which you are willing to buy or sell units.

#### Timina

In general, market prices of ETFs can be more volatile around the start and end of the trading day. Consider using a limit order or placing a trade at another time during the trading day.

## Who is this ETF for?

This ETF may be suitable for investors who:

- · are investing for the long-term
- want exposure to global technology companies that are deemed to be innovators
- are willing to accept some short-term volatility for potentially higher long-term returns
- · are contributing to the growth component of a diversified portfolio
- · are very comfortable with the ups and downs of the stock market

#### A word about tax

In general, you'll have to pay income tax on any money you make on an ETF. How much you pay and/or when you pay depends on the tax laws where you live, the type of distributions made by the ETF and whether or not you hold the ETF in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your ETF in a non-registered account, you must include taxable ETF distributions in your taxable income, whether you get them in cash or have them reinvested.

# How much does it cost?

This section shows the fees and expenses you could pay to buy, own and sell units of the ETF. Fees and expenses – including trailing commissions – can vary among ETFs.

Higher commissions can influence representatives to recommend one investment over another. Ask about other ETFs and investments that may be suitable for you at a lower cost.

#### 1 Brokerage commissions

You may have to pay a commission every time you buy and sell units of the ETF. Commissions may vary by brokerage firm. Some brokerage firms may offer commission-free ETFs or require a minimum purchase amount.

#### 2 ETF expenses

You don't pay these expenses directly. They affect you because they reduce the ETF's returns.

As of June 30, 2024, the ETF's expenses were 0.56% of its average value. This equals \$5.60 for every \$1,000 invested.

## Management expense ratio (MER)

This is the total of the ETF's management fee and operating expenses, costs or fees incurred by the ETF which are not paid for by the manager. TDAM waived some of the ETF's expenses. If it had not done so, the MER would have been higher.

# **Trailing commission**

The trailing commission is an ongoing commission. It is paid for as long as you own the ETF. It is for the services and advice that your representative and their firm provide to you.

# What if I change my mind?
