#### SECOND AMENDING AGREEMENT TO CUSTODIAL AGREEMENT

THIS SECOND AMENDING AGREEMENT TO CUSTODIAL AGREEMENT (this "Agreement") is made as of the 30<sup>th</sup> day of June, 2023.

#### BY AND AMONG

- (1) THE TORONTO-DOMINION BANK, a bank named in Schedule I to the *Bank Act* (Canada), whose executive office is at 66 Wellington Street West, 21<sup>st</sup> Floor, TD Bank Tower, Toronto, Ontario, Canada M5K 1A2 as Account Bank (in its capacity as Seller, Servicer and Cash Manager);
- PARTNERSHIP, a limited partnership formed under the laws of the Province of Ontario whose registered office is at 66 Wellington Street West, 21st Floor, TD Bank Tower, Toronto, Ontario, Canada M5K 1A2 by its managing general partner TD COVERED BOND (LEGISLATIVE) GP INC., as Guarantor; and
- (3) COMPUTERSHARE TRUST COMPANY OF CANADA, a trust company formed under the laws of Canada, whose registered office is at 100 University Avenue, 8<sup>th</sup> Floor, Toronto, Ontario, Canada M5J 2Y1, as Custodian and Bond Trustee.

WHEREAS the parties entered into a custodial agreement dated June 25, 2014, as amended by a first amending agreement on September 7, 2017 (the "Custodial Agreement");

**AND WHEREAS** the parties hereto have agreed to amend the Custodial Agreement pursuant to the terms of this Agreement in accordance with Section 13.1 of the Custodial Agreement, Section 3 of the Master Definitions and Construction Agreement, Clause 21.2 of the Trust Deed and Section 7.02 of the Security Agreement;

**NOW THEREFORE IT IS HEREBY AGREED** that in consideration of the mutual covenants and agreements herein set forth, the parties agree as follows:

# **ARTICLE 1– AMENDMENTS**

## 1.01 <u>Amendments</u>

- (1) The Custodial Agreement is amended by deleting section 4.6 in its entirety and replacing it with the following:
  - "4.6 Forthwith upon the occurrence of an event described in Section 7.1(a) (including clause (vi) thereof) of the Mortgage Sale Agreement, the Seller, or the Servicer or the Cash Manager on behalf of the Seller, shall deliver to the Custodian (a) for safekeeping, updated (i) Eligible Loan Details, and (ii) Substitute Asset Details in respect of all Loans and their Related Security and Substitute Assets held by the Guarantor, respectively, and (b) to the extent not previously delivered to the Custodian, each of the powers of attorney required by Section 4.1(a) (unless replaced by Section 4.5) and

Section 4.5, as applicable, together with documentary evidence of chain of title to the Loans and their Related Security and Substitute Assets held by the Guarantor and duly executed copies of any other registrable forms of assignment that may be required by the Guarantor in order to Perfect the sale, assignment and transfer of the Loans and their Related Security from the Seller to the Guarantor, including for greater certainty, any additional documents that may be required for such purposes pursuant to the CMHC Guide or otherwise."

- (2) The Custodial Agreement is amended by deleting section 10.6 in its entirety and replacing it with the following:
  - "10.6 The Guarantor shall, to the extent that DBRS, Moody's, or Fitch is a Rating Agency, provide 10 Business Days' prior notice to DBRS, Moody's, or Fitch, as applicable, of the replacement of the Custodian upon the termination or resignation thereof."

### **ARTICLE 2– MISCELLANEOUS**

# **<u>Further Assurances</u>**

Each of the parties hereto will from time to time execute and deliver all such further documents and instruments and do all acts and things as any of the other parties may reasonably require to effectively carry out or better evidence or perfect the full intent and meaning of this Agreement.

#### 2.02 Other Amendments

Except as expressly amended, modified and supplemented hereby, the provisions of the Custodial Agreement are and shall remain in full force and effect and shall be read with this Agreement, *mutatis mutandis*. Where the terms of this Agreement are inconsistent with the terms of the Custodial Agreement (prior to its amendment hereby), the terms of this Agreement shall govern to the extent of such inconsistency.

#### 2.03 Governing Law

This Agreement is governed by and will be construed in accordance with the laws of Ontario and the federal laws of Canada applicable therein.

#### 2.04 Interpretation

Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Custodial Agreement (prior to its amendment hereby) and in the Third Amended and Restated Master Definitions and Construction Agreement dated June 30, 2023, as amended, supplemented or restated from time to time, by and among The Toronto-Dominion Bank, TD Covered Bond (Legislative) Guarantor Limited Partnership, Computershare Trust Company of Canada, 8638080 Canada Inc., TD Covered Bond (Legislative) GP Inc., Ernst & Young LLP,

Citibank, N.A. London Branch, Citigroup Global Markets Europe AG and Citibank, N.A., as the context requires.
