**Composition of the Assets**

The information provided in the tables below summarizes a portfolio of assets in which the Trust and The Toronto-Dominion Bank hold an undivided co-ownership interest as at September 30, 2017. The Trust Assets consist primarily of Co-Ownership Interests in such portfolio of assets. These tables are not necessarily indicative of the composition of the portfolio after September 30, 2017.

As of September 30, 2017, the average beacon score for these assets was 787. Beacon scores are generated by Equifax Credit Bureau and range from approximately 400 (poor) - 900 (perfect) and are a common measure used by banks and other financial institutions of a borrower's creditworthiness, determined by weighing a number of factors including payment history, current debts and age of accounts.
