Interest Payment Determination Date:	The date two U.S. Government Securities Business Days before each Interest Payment Date.

Optional Redemption by the Issuer for Tax Reasons:	In certain circumstances where the Issuer has or will become obligated to pay additional amounts (as described in the pricing supplement), the Issuer may, at its option, redeem the Notes in whole, but not in part, at any time

before maturity, after giving not less than 10 nor more than 60 calendar days' notice to the holders of the Notes, at a redemption price equal to 100% of their principal amount together with accrued interest, if any, to, but excluding, the redemption date. See "Terms of the Notes — Redemption for Tax Reasons" in the pricing supplement.

Concurrent Offerings: US\$900,000,000 0.300% Senior Medium-Term Notes, Series C, due 2023 and US\$1,300,000,000 1.200% Senior Medium-Term Notes, Series C, due 2026.  
The settlement of the Notes is not contingent on the settlement of the concurrent offerings.
